

Project Overview:	<p>FMG is developing a new mine and associated infrastructure at its Eliwana Site (Eliwana Project) located in the Pilbara region of Western Australia.</p> <p>The planned infrastructure includes 143km of rail and a 30mtpa dry ore processing facility, with production commencing in September 2020.</p>
