<p>Scope of Works</p>	<p>Due to the limited amount of suspended formwork John Holland is preferably looking for subcontractors to provide the complete service of form, reo and pour (FRP) for SQCP-S2.</p> <p>The Scope would include but is not limited to:</p> <ul style="list-style-type: none"> <li>a) Design Obligations (temporary works for suspended formwork and stairs).</li> <li>b) Trade Specific Works             <ul style="list-style-type: none"> <li>i. Formwork and support systems – slab on ground, suspended slabs, slab detailing and stairs;</li> <li>ii. Detailed excavation</li> <li>iii. Steel Reinforcement supply and installation; and</li> <li>iv. Concrete supply, pump, place and finish.</li> </ul> </li> </ul> <p>Subcontractors can tender for part scope by registering interest in the below individual packages:</p> <ul style="list-style-type: none"> <li>1. SOG formwork, detailed excavation, pour concrete including pump, place, finish. Supply of concrete can be excluded.</li> <li>2. Reo place all slabs including SOG, suspended, and stairs etc. Supply of reo can be excluded.</li> <li>3. Suspended formwork and stairs includes temporary works designs.</li> </ul>
<p>Project Summary</p>	<p>In June 2019 Queensland Government announced plans to build a new 1000 bed men’s prison near Gatton with the \$653M facility planned for completion in 2023. The Stage 2 expansion will:</p> <ul style="list-style-type: none"> <li>• Address overcrowding across the correctional system in Queensland</li> <li>• Improve safety of correctional officers and prisoners</li> <li>• Deliver economic boost and additional jobs during both construction and operation</li> </ul> <p>The Queensland Government has determined that this new correctional centre will adopt a ‘health and rehabilitation’ operating model which will support safer communities through enhanced mental health and drug and alcohol rehabilitation services for prisoners, with a focus on addressing the ice epidemic and its link to violent and property crime.</p>



Location of Works	The Southern Queensland Correctional Precinct is located at Grindle Road, Spring Creek, about 12 km north-east of Gatton and about 100 km south west of Brisbane in the Lockyer Valley
Delivery Schedule	<p>Design Development is currently in progress and is anticipated to be complete by Early December 2020. Subcontractor and supplier procurement will commence in September 2020.</p> <p>Early Site works are planned to commence in December 2020. Main works are planned for commencement in January 2021.</p>
