John Holland Group and ICN hereby invites Registration of Interest from respective trade contractors and suppliers for the Logan Hospital Expansion Project for the **Distributed Antenna System**. All ROI submissions should be made through the ICN Gateway.

Scope of Works	Supply & installation of Distributed Antenna System including but not limited to; The Subcontractor will be responsible for supplying and installing all labour, plant, materials, insurances, equipment, and supervision necessary for a Distributed Antenna System (DAS) within Building 3. A new 2-hour fire rated DAS plantroom will be incorporated in the new Level 8 plantroom, including lighting, power, security (CCTV and Access Control), air conditioning etc. DAS passive cabling is to be provided to both the new and existing floor areas.
Project Summary	Logan is one of the fastest growing regions in the state with more than 70,000 additional dwellings expected in the area by 2041. This expansion will enhance the clinical services delivered at the Logan Hospital and improve facilities for patients, visitors and staff. The project includes: <ul style="list-style-type: none"> • an additional 195 beds and additional 11 treatment spaces • a vertical expansion of Building 3 (emergency department building), delivering four new floors • building-in of the ground floor of Building 3 • refurbishment of clinical, clinical support and operational service support areas in the other existing hospital buildings.
Location of Works	Logan Hospital Campus is located on the corner Loganlea Road & Armstrong Road, Meadowbrook Queensland 4131, about 29 km South of Brisbane, about 43km East of Ipswich and about 50km North of Southport.
Delivery Schedule	Design Development is currently in progress and is anticipated to be complete by Early 2021. Subcontractor and supplier procurement will commence in April 2020. Early Site works are planned to commence in May 2020. Main works are planned for commencement in August 2021.
