<p>Project Summary</p>	<p>Logan is one of the fastest growing regions in the state with more than 70,000 additional dwellings expected in the area by 2041.</p> <p>This expansion will enhance the clinical services delivered at the Logan Hospital and improve facilities for patients, visitors and staff.</p> <p>The project includes:</p> <ul style="list-style-type: none"> • an additional 195 beds and additional 11 treatment spaces • a vertical expansion of Building 3 (emergency department building), delivering four new floors • building-in of the ground floor of Building 3 • refurbishment of clinical, clinical support and operational service support areas in the other existing hospital buildings.
<p>Location of Works</p>	<p>Logan Hospital Campus is located on the corner Loganlea Road & Armstrong Road, Meadowbrook Queensland 4131, about 29 km South of Brisbane, about 43km East of Ipswich and about 50km North of Southport.</p>
<p>Delivery Schedule</p>	<p>Design Development is currently in progress and is anticipated to be complete by Late 2021. Subcontractor and supplier procurement will commence in August 2021.</p> <p>Early Site works are planned to commence in July 2021. Main works are planned for commencement in October 2021.</p> <p>ICT System Integrator works are planned for commencement in October 2021.</p>
