General Description

Rio Tinto's Amrun Project is located approximately 40 km south-west of Weipa in far North Queensland, Australia. The package will include the following scope:

The Primary Contractor shall furnish all personnel, supervisor, materials, transportation, equipment, tools, consumable and permits necessary to provide a waste management service for the construction activities involved with the Project.

The scope of works will include the following:

- Mobilisation and demobilisation of all personnel and plant and equipment to and from site;
- Management of waste including supply of a collection, consolidation, compaction and disposal services;
- Disposal of waste at licensed waste receptacle facilities.
- Provide suitably-qualified personnel who possess the necessary licence/certification and experience required to complete the waste management works.
- Supply special task specific personal protective equipment (PPE)
- Furnish all labour, tools, and equipment (including but not limited to vehicles, engineering services, surveying services, supervision, consumables, temporary facilities, certification services, maintenance services and all safety equipment.
- Ensure ensuring the intended vessel(s) for charter is fit for- purpose and suitable for operation within the range of all environmental and weather conditions for the Project.
- Operate and provide services that comply with Country, State and Local requirements.
- Operate and provide services that adhere to the Standard for Marine Activities in Weipa Port, North Queensland Bulk Ports and Maritime Safety Queensland.
