The IPR shall draw on the expert knowledge of the Contractor to identify any areas where the BFX Project is exposed to risks from a technical perspective.• Carrying out an IPR with the intent to achieve functional excellence in the BFX investment. <p>The contractor will be required to deliver the following:</p> <ul style="list-style-type: none">• The IPR team will produce documented evidence of technical/function reviews and engagements with the BFX team and Engineering Contractor.• A detailed IPR report, including a risk assessment and evidence of any technical non-compliance. The IPR Report may conclude that additional checks are required to provide a level of confidence in the integrity of the design.• An IPR summary report for the BHP Investment Review Committee.• Formal IPR review meetings and presentation to BHP and the BFX Engineering Contractor.• Produce a final interpretive and report. <p>At all times during the delivery of the services the contractor will be expected to adhere to BHP safety policies and standards including participation in BHP's field leadership program.</p>
